The Rodeo Drive Committee announces new executive leadership to steward iconic fashion thoroughfare into the future

Kay Monica Rose elected president

(Beverly Hills, CA–July 24, 2023) – The Board of Directors of the Rodeo Drive Committee (RDC) announced today the election of **Kay Monica Rose** as president of the Rodeo Drive Committee, effective July 1, 2023. Rose has appointed a team of new and returning officers to the Executive Committee to preserve Rodeo Drive's legacy and continue the Committee's mission, established in the 1970s, to advance the iconic street as a leading, international, luxury fashion destination.



The newly-formed Executive Committee, led by President **Rose**, comprises returning Vice President **Kiersten Dunn**, Vice President and former twice-RDC President **Kathy Gohari**, newly appointed Vice President **Chelle Kearney**, and returning Treasurer and former RDC President **Mark Tronstein**.

"At the heart of my vision for Rodeo Drive is the preservation and advancement of an unmatched legacy of exceptional craftsmanship, innovation, and customer service," said Rose. "With the expertise and commitment of our executive committee and members and the support and guidance of the City of Beverly Hills and city partners, our focus will be to nurture a safe, welcoming and vibrant community and to continue to reinvent the street of dreams."

The Rodeo Drive Committee was co-founded in 1977 by the "Godfather of Rodeo Drive" **Fred Hayman**. At the time of the Committee's founding, Hayman was chairman of the Rodeo Drive Association, a consortium of store owners determined to put the street on the world map, and president of Giorgio Beverly Hills, the legendary Rodeo Drive boutique. Among the Committee's original goals was to promote Rodeo Drive as America's answer to the glamor of Rome's Via Condotti, London's New Bond Street and Paris's Faubourg St-Honoré, and included a major campaign to attract national and international attention to Rodeo Drive, the boulevard that claimed, at the time, to have the highest concentration and diversity of luxury retail stores in the world. Today, as a result of the dedicated stewardship of the Rodeo Drive Committee, the retail experience on Rodeo Drive remains unparalleled.

Among Rose's first initiatives as President is *Rodeo Drive Celebrates*, a new annual program conceived by the Rodeo Drive Committee to celebrate the exemplary craftsmanship and creativity in fashion, timepieces and fine jewelry on the legendary street. The program will take place every year over two dedicated weeks in summer and fall. *Rodeo Drive Celebrates Fashion* will take place for the first time from August 7-13, 2023, and *Rodeo Drive Celebrates Timepieces & Fine Jewelry* will follow from October 1-7, 2023. Among the celebratory events and happenings hosted by member boutiques and businesses are collection previews and trunk shows, personalized VIP styling sessions, exclusive product offerings and special in-store invitations.

A true California native, Kearney's love for fashion has been honed through her educational pursuits. She holds a BFA in Womenswear from the School of the Art Institute Chicago and a coveted MFA in Menswear and Textile from Academy of Art University in San Francisco. Her journey in the world of luxury fashion began as a talented tailor, where she cultivated immense respect for the artistry of design and witnessed firsthand the transformative power that fashion possesses.

Kearney cherishes the opportunity to create unforgettable experiences for her clients and the global community that Rodeo Drive hosts. With a deep sense of honor, she strives to develop even greater acclaim for its remarkable community.
